(3) RAC is ordered to destroy the Management Test results and not consider the scores or narratives in making any employment decision for its Illinois employees. However, Plaintiffs have ten days from the entry of this order to object to the destruction of documents if Plaintiffs feel they need access to these documents for the present litigation. RAC should not destroy any test results prior to ten days from entry of this order. (4) Plaintiffs' requested relief of amending the class certification order is DENIED. (5) A telephone status conference is set for August 26, 2005, at 10:00 a.m. to discuss the scheduling of the trial in this matter. (6) The court will address the issue of attorney fees and costs, as well as compensation for Karraker as class representative, at the conclusion of this litigation.
