**ORDER**

The above-captioned case was recently consolidated with Civil Case No. 06-12311, *Avalos, et al. v. Cintas Corp.* During the process of consolidating the cases, it came to the attention of this Court that several inaccuracies had developed on the electronic docketing system due to the way various pleadings had been entered on the docket. This order corrects these docketing inaccuracies.

In the above-captioned case, the Equal Employment Opportunity Commission (“EEOC”) is currently listed on the electronic docketing system as a movant and as a third-party plaintiff. In the companion case of *Avalos, et al. v. Cintas Corp.*, the EEOC is correctly listed as an intervening plaintiff. Since the EEOC’s proper position in the current suit is as an intervening plaintiff (also known as “plaintiff-intervenor”), it will be listed as such in the above-captioned case and its positions as movant and as third-party plaintiff will be removed from the docket. Similarly, Cintas Corporation is incorrectly listed as a third-party defendant, and its position as such will be removed from the docket.

**ACCORDINGLY, IT IS HEREBY ORDERED** that the inaccuracies to the electronic

docketing system in the instant case, Civil Case No. 04-40132, are corrected in a manner as specified in this order.
