**STIPULATED ORDER FOR
DISENGAGEMENT OF OBJECTIVE S1.1.1**


THIS MATTER, is before the Court by the agreement of the parties. On December 22, 2015, Defendants sought a formal written determination from the Jackson Compliance Administrator (the "JCA") related to Objective S1.1.1 "Define 'Abuse, Neglect and Exploitation' (ANE) consistent with New Mexico Statutory Adult Protective Services (APS) definitions."

On January 21, 2016, the JCA issued a written determination, Doc. 2080, finding that "DOH has met the requirements of evaluative component S1.1a and therefore the criteria for the Objective S1.1.1 has been met."

Plaintiffs have assented to the disengagement of S.1.1. The Court, having reviewed the matter and otherwise being apprised, finds that disengagement is appropriate.

NOW THEREFORE, it is found that Defendants have satisfied Objective S1.1.1 “Define ‘Abuse, Neglect and Exploitation’ (ANE) consistent with New Mexico Statutory Adult Protective Services (APS) definitions.”

IT IS THEREFORE ORDERED that the Court’s oversight of the aforesaid Objective S1.1.1 be and hereby is disengaged as contemplated by the Stipulated Agreement on Disengagement Process for Revised Table IV (Doc. 2073). In the event that there is evidence of substantial noncompliance with Objective S1.1.1, the Plaintiffs may request that the Court reassert its supervision over this Objective, or the Court, at its discretion, may re-establish its oversight of this Objective.
