**FOURTH JOINT STATUS REPORT AND  
JOINT MOTION FOR BRIEFING SCHEDULE**

Pursuant to the Court’s minute Order dated November 4, 2018 (the “Order,” ECF No. 21), the American Civil Liberties Union of Maine (“Plaintiff”), and the U.S. Department of Homeland Security and U.S. Customs and Border Protection (collectively, “Defendants”), hereby file this Fourth Joint Status Report and Joint Motion for Briefing Schedule addressing the status of production in this case under the Freedom of Information Act (“FOIA”) and the parties’ proposed schedule for future proceedings.

Since the last status report, the Defendants have re-produced several responsive documents with fewer redactions. However, even after this updated production, there remain numerous redactions that the Plaintiff contends are unsupported by the FOIA statute. Accordingly, the parties request the Court’s adjudication of the legal question of whether FOIA exemptions apply to the redacted material. In furtherance of the Court’s decision on these issues, the parties propose to submit the redacted and the un-redacted records for the Court’s *in camera* review, along with simultaneous letter briefs addressing the claimed exemptions. The parties believe this would be the most efficient resolution of the dispute, as there is only a small quantity

of challenged documents, lending the case to non-burdensome *in camera* review. Specifically, the parties propose the following briefing schedule:

- **February 1, 2019:** ACLU of Maine will designate the challenged redacted documents.
- **February 22, 2019:**
  - ACLU of Maine will file the challenged redacted documents and its memorandum opposing the claimed exemptions (no longer than 10 pages).
  - Defendants will submit the un-redacted documents for *in camera* review and will file their memorandum in support of the claimed exemptions (no longer than 10 pages).
- **March 8, 2019:** The parties will submit response briefs (no longer than 7 pages).
- The parties are amenable to the review of the subject documents and adjudication of their dispute regarding all redactions proceeding before the assigned Magistrate Judge.

The Court could then schedule oral argument as it deems necessary.

WHEREFORE, the Parties jointly request that they be permitted to file simultaneous briefs addressing the legal adequacy of the challenged redactions in the Defendants' FOIA production, under the proposed schedule set forth above.
