AGREED FINAL JUDGMENT BETWEEN
PLAINTIFF RICARDO GARZA AND DEFENDANTS

BE IT REMEMBERED, that on this day, Plaintiff Ricardo Garza and Defendants, Dallas County and Texas, (collectively, the "Parties"), by and through their respective counsel, hereby agreed to and requested entry of this final judgment.

Final resolution of the controversy between Plaintiff Ricardo Garza and Defendants has been reached in a separately executed settlement agreement, the terms of which are incorporated by reference herein. Pursuant to that agreement, all claims and causes of action, which were or could have been asserted by and between the Parties have been compromised and settled, and that Plaintiff Ricardo Garza shall take nothing against Defendants, except as ordered herein, and that all court costs and attorneys' fees shall be taxed against the party incurring the same.

NOW, THEREFORE, in accordance with the Parties' compromise and settlement it is accordingly,

ORDERED, ADJUDGED, AND DECREED that the State of Texas shall pay Plaintiff Ricardo Garza nine thousand five hundred dollars (\$9,500), in complete and total satisfaction of all his claims, including claims for costs and attorneys' fees.

All relief not expressly granted herein shall be denied.
