CONSENT ORDER

Upon consideration of the Report of the Special Officer on Medical Care at the District of Columbia Jail, the Special Officer's Outline of her Findings on Mental Health Care at the District of Columbia Jail, the Expert Reports on Medical and Mental Health Services at the District of Columbia Jail, the Plaintiffs' Motion that the Court Adopt the Special Officer's Report on Medical Care at the District of Columbia Jail as the Court's Findings and that the Defendants be held in Contempt of Court, the Court's findings in its April 20, 1993 Order Appointing Special Officer, the Court's findings in its March 5, 1993 Order, the defendants' acknowledgement and representation

that while it disagrees with some of the statements in the Special Officer's Reports, it is in non-compliance with numerous material provisions of the orders of this Court, that it intends to remedy its non-compliance and does not oppose entry of this remedial order, and the entire record in this case,

it is by this Court this 16th day of March, 1994

ORDERED that the defendants are found to be in Contempt of this Court, and it is further

ORDERED that the Special Officer shall, within 120 days of this Order submit a plan to cure the defendants' contempt and that will insure that the defendants render medical and mental health services to prisoners at the Jail in a manner consistent with the United States Constitution, and it is further

ORDERED that the Special Officer's remedial plan shall address all issues raised in her reports, the Expert Reports on Medical and Mental Health Services, as well as any additional issue that may come to the attention of the Special Officer or the Court that adversely impacts on the defendants' compliance with the Court's orders concerning the delivery of medical and mental health services at the Jail or that adversely impacts on the defendants' delivery of medical and mental health services at the Jail in a manner consistent with the United States Constitution, and it is further

ORDERED that the remedial plan shall include a time table for implementation, graduated automatic fines for failure to meet


implementation deadlines, and a procedure for the defendants to report on their compliance, and it is further

ORDERED that in developing the remedial plan that the Special Officer shall consult with the defendants and their counsel, with counsel for the plaintiffs, and with such experts as she deems necessary, the fees and expenses of any expert hired pursuant to this paragraph shall be paid by the District of Columbia, and it is further

ORDERED that the defendants shall implement the remedial plan in accordance with the time table established by the Special Officer unless good cause is shown by any party why the plan should not be implemented or should be modified, and it is further


ORDERED that the Special Officer shall file, and the defendants shall implement, such interim remedial plans as the Special Officer deems necessary in order to address conditions that, in the opinion of the Special Officer, must be addressed on an expedited basis, and it is further

ORDERED that the defendants shall implement within 30 days the recommendation of the Special Officer for a compliance monitor contained at 127-8 of her report.
