**ORDER ON PLAINTIFFS’ MOTION TO APPROVE
CLASS CERTIFICATION NOTICE**

Plaintiffs move for approval of the Notice of Class Certification and Opt-Out Form submitted by the Plaintiffs as Exhibits 1 and 2. (*See* Filing Nos. 90-1, 90-2). Having reviewed the forms and noting no objection filed by Defendants, the court finds the forms meet the requirements of Federal Rule of Civil Procedure 23(c)(2) and therefore, the motion (Filing No. 90) is **GRANTED**.

IT IS HEREBY ORDERED that the following Notification Procedures will be used:

1. Defendants shall provide Plaintiffs with the current mailing address on file with Defendants for each individual identified in Exhibit 2. (*See* Filing 90-2, Identified Class Members).

2. Defendants shall consult any regularly available database used to track incarcerated persons and identify any class member who is presently incarcerated by facility and inmate number.


3. Defendants shall provide the above information within thirty (30) days of the entry of this Order.

4. Class Counsel shall corroborate addresses provided by Defendants through LexisNexis or Westlaw.

5. Within thirty (30) days of receiving the above information from Defendants, Class Counsel shall send via U.S. Postal Service the Approved Notice and Opt Out Form to all class members for which addresses are available.

6. Class Counsel shall create a website which contains, at a minimum, a copy of the Notice of Class Certification, Complaint and Amended Complaint, Defendants' Answer, the Opt Out Form, and an electronic contact link to allow class members to update their contact information.
