## ORDER TRANSFERRING CLAIMS FOR ADMINISTRATIVE PURPOSES AND CLOSING CASES

This action was brought by twenty-six plaintiffsalleging violations of their civil rights while they were detainees at the Saginaw County jail. Sim ilar claims were brought by nine additional plaintiffs in the case of *Christopher Brabant, et al. v. Saginaw County*, docket no. 05-10030; and by sixty-three more plaintiffs in the case of *James Abner, III, et al. v. Saginaw County*, docket no. 05-10323. These cases were consolidated for pretral proceedings and settlement discussions. The parties have engaged in settlement efforts (including case evaluation); and in the *Rose* matter a trial was held on the claims of four of the plaintiffs. There now remain two plaintiffs in the *Rose* case

and one plaintiff in the *Brabant* case. Thirty-three plaintiffs remain in the *Abner* case.

The Court sees no purpose in ma intaining three open files in these cases. Therefore, the

Court will transfer the claims of Lisa Renee Brandimore and Robin Renee Thomas from the Rose

case and the claims of Sherry Bill in the Brabant case all to the Abner case. The Rose and Brabant

files will be closed.

Accordingly, it is **ORDERED** that the claims of Lisa Renee Brandimore and Robin Renee

Thomas are transferred for further adjudication from the present matter to be joined in the matter

of James Abner, III, et al. v. Saginaw County , docket no. 05-10323. This s transfer is for

administrative purposes only and will not alter the nature or timing of these claims.

It is further **ORDERED** that the claims of Sherry Bill are transferred for further adjudication

from the case of Christopher Brabant, et al. v. Saginaw County, docket no. 05-10030 to be joined

in the matter of James Abner, III, et al. v. Saginaw County, docket no. 05-10323. This transfer is

for administrative purposes only and will not alter the nature or timing of these claims.

It is further **ORDERED** that the present matter and the case of *Christopher Brabant*, et al.

v. Saginaw County, docket no. 05-10030 are CLOSED.
