Dear Michael,

Thanks for your letter and words of encouragement about the forthcoming settlement in our Denver case, E.R. v. McDonnell. When I read the advance sheets and talk to colleagues around the country, I feel extremely fortunate that things have gone so well for us (so far, at least) in this case.

Here are copies of the Settlement Agreement and the Order and Memorandum of Agreement to Amend Settlement Agreement and Order. Although the Orders have been signed by the court, we are actually still in the stage of providing notice to the plaintiffs class. The hearing in final approval of the settlement is still set for September 1, 1995.

You will see some strange provisions in the Agreement having to do with contingent provisions if the federal STOP legislation passes. These provisions represent what the parties agreed upon to insulate the Agreement from being dissolved under the terms of that legislation.

Maybe I'll see you in September for the Board meeting; hope your summer is going well.
