Should this Court grant Defendants' Motion for a Stay Pending Appeal (Doc. <u>315</u>), Defendants shall deliver the October 2014, April 2017, May 2017, and June 2017 issues of Prison Legal News to current ADC-prisoner subscribers within 30 days of the lifting of the stay. IT IS FURTHER ORDERED if this Court denies Defendants' Motion for a Stay Pending Appeal (Doc. <u>315</u>), and Defendants do not file a motion for a stay pending appeal with the Ninth Circuit Court of Appeals within fourteen days of this Court's denial, Defendants shall have forty-five days from this Court's order denying a stay pending appeal (Doc. <u>315</u>) to deliver the subject issues of Prison Legal News. IT IS FURTHER ORDERED if this Court denies Defendants' Motion for a Stay Pending Appeal (Doc. <u>315</u>), and Defendants file a motion for a stay pending appeal with the Ninth Circuit Court of Appeals within fourteen days of this Court's denial, delivery of the subject issues of Prison Legal News shall be stayed until either 30 days after the Ninth Circuit Court of Appeals' order denying a stay pending appeals, or 30 days after the lifting of any stay issued by the Ninth Circuit Court of Appeals.
