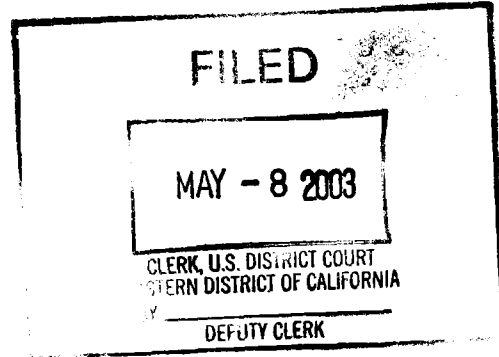

Plaintiff is a state prisoner proceeding pro se. He filed suit pursuant to 42 U.S.C. § 1983 alleging that he is an adherent of the religion of Wicca and that defendant prison officials violated his rights protected by the First Amendment to the Constitution of the United States.

On October 28, 1996, the court vacated the referral to the assigned magistrate judge, retained this case for trial, and appointed the Civil Rights Clinic at King Hall School of Law to represent plaintiff. Magistrate Judge Gregory G. Hollows subsequently settled the case.

1 Plaintiff has now filed numerous documents alleging that
2 defendants are violating the terms of the Settlement Agreement.
3 Accordingly, this court's October 28, 1996 withdrawal of the
4 referral is VACATED. This matter is REMANDED to the magistrate
5 judge for all proceedings consistent with Local Rule 72-302(c)
6 (17).

7 IT IS SO ORDERED.
