If he is not being provided the those things in the new facility, then it would seem that the complaint is not moot. If ADX's revised pill line procedures that caused plaintiff's complaint about administration of medications during Ramadan to be moot, see id., no longer apply in the new facility, then that claim is no longer moot. If he is being provided all those things at the new facility, then his claims are moot. Thus, I agree that the defendant cannot automatically moot the complaint by transferring the plaintiff to a different facility and arguing that the claims focused solely on the ADX. Of course they did, because that's where he was, but this Court's focus in on the substance of what he claims to have been denied and whether the denial violated his constitutional rights. I do not understand how the transfer affects this Court's jurisdiction in any way. It appears that neither party is fully aware, as yet, whether and to what degree those claims apply to his situation in the new facility. It might be appropriate to supplement or amend the complaint to adjust to the new facility so long as the focus remains specifically on the three items that survived the motion to dismiss (or four if the Ramadan issue is no longer moot). But the Proposed Supplemental Complaint asserts new facts and issues dating back to 2015, particularly concerning the legitimacy of transfers of the plaintiff inside and outside the ADX facility.
