CONSENT ORDER

This matter concerning Defendants' compliance with the Court's Orders on mental health care and medical care at the Lorton facilities having been brought before the Court on July 9, 1996, and the parties having consented hereto, it is hereby ORDERED that Defendants shall report to the Court by September 9, 1996, as to whether they have hired an appropriately qualified systemwide medical coordinator. It is

FURTHER ORDERED that the parties shall appear for a hearing on October 9, 1996 at 1:30 p.m., at which time, if Defendants have hired a systemwide medical coordinator, (1) the Special Officer shall report to the Court as to whether in her view the person whom Defendants have hired is qualified to undertake the tasks necessary to improve systemwide compliance with the Court's Orders concerning medical and mental health care, and (2) the new systemwide medical coordinator will report to the Court regarding his or her plans to increase Defendants' compliance with the Court's Orders concerning medical and mental health care. It is

FURTHER ORDERED that if Defendants have hired a systemwide medical coordinator by September 9, 1996, the Special Officer shall report to the Court at such time as she deems appropriate, after consulting with the new coordinator and the parties, as to whether the Court should enter additional orders regarding the powers and responsibilities of the systemwide medical coordinator so as to better enable him or her to improve compliance with the Court's existing Orders. It is .

FURTHER ORDERED that if Defendants have not hired a systemwide medical coordinator by September 9, 1996, the parties shall present proposals at the October 9, 1996 hearing as to how to improve Defendants' compliance with the Court's existing Orders regarding medical and mental health care, including but not limited to how to improve the medical leadership within the Department of Corrections.


