Upon consideration of the Motion for Modification of Consent Decree submitted herein, and it appearing to the Court that the Motion should be granted;

IT IS ORDERED that the Motion for Modification of Consent Decree be and is hereby GRANTED and Paragraph 1.1, 2.2, 2.4(a) and Exhibit E-1 of Exhibit E of the Consent Decree is modified as follows:

Paragraph 1.1

Increase the maximum number of inmates to be housed at Louisiana State Penitentiary from 4,878 to 5,108.

Paragraphs 2.2, 2.3 and Exhibit E-1

Unit 3 Upper - 40 beds  
Unit 3 Lower - 40 beds  
Unit 4 Left - 75 beds  
Unit 4 Right - 75 beds

Increase the security staffing for Camp F from 6 correctional officers and 4 supervisor/other to 18 correctional officers and 4 supervisor/other. The distribution of the 12 additional correctional officers will be as follows:

(1 for C Team, 1 for D Team);  
Unit 3 Lower - 1 correctional officer per shift from 5:30 P.M. to 5:30 A.M.

Unit 3 Upper & Lower - 1 correctional officer per shift from 5:30 A.M. to 5:30 P.M.  
(1 for A Team, 1 for B Team);
