STIPULATION OF DISMISSAL

The parties, by their respective counsel, submit this Stipulation of Dismissal pursuant to Fed.R.Civ.P. 41(a)(ii). The parties state the following: On April 12, 2012, the Court issued a Memorandum and Order (Docket No. 260) allowing the parties' Joint Motion to Approve the Settlement Agreement (Docket No. 248), staying this action, retaining jurisdiction, and providing for the dismissal of this action three years after the date of its Order. On the same date, the Court ordered this action administratively closed (Docket No. 261). Section VIII(B) of the Settlement Agreement provides for termination of the Court's jurisdiction at the end of the three year settlement period with respect to any provision or provisions for which there has been no outstanding determination that the Department of Correction is not in substantial compliance. As such determination has

been neither requested nor entered, the three year term of the Settlement Agreement and the jurisdiction of the Court terminated on April 13, 2015.
