3. The list of prisoners who are on observation status for suicide risk can be produced and available for you when you arrive on the 17th.
4. Please explain the rationale for the request of the list of the prisoners on the mental health caseload on 8/27/14 and 9/17/14?
5. There is no such thing as a suicide incident report. There is a critical incident report but that was already provided to you on August 27/28. Peer review reports are not provided.

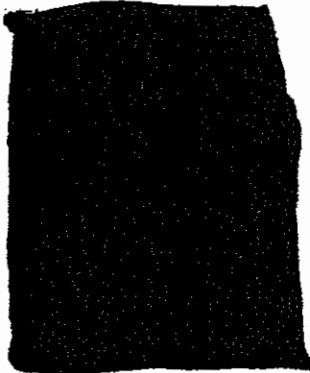
