Additionally, nothing in this Stipulation and Order limits or precludes a Plaintiff from seeking injunctive relief if she is at imminent risk of physical harm related to DOCCS failure to protect her from harm during Stay or the 9–month period of the Monitored Stay. If Plaintiffs do not move to lift the Monitored Stay pursuant to the terms set forth in paragraph 4, during the nine–month period of the Monitored Stay, the Action shall be automatically dismissed with prejudice, and without costs or fees to any party, on the date that the nine–month Monitored Stay period expires. If Plaintiff move to lift the Monitored Stay during the nine–month period and that motion is denied, the Action shall automatically be dismissed with prejudice, and without costs or fees to any party, on the date Plaintiffs' motion is denied. It is agreed and understood by the Parties that, upon dismissal of the Action pursuant to paragraph 8, the Court shall not retain any jurisdiction it may have had to enforce the terms of the Settlement Agreement and as further set forth in this Stipulation.
