**I. STIPULATION**

The Sharp plaintiffs' counsel shall be awarded the following fees and costs from January 1, 1999 until November 11, 1999.

1. Heller Ehrman White & McAuliffe, as attorneys for the Sharp plaintiffs, shall be awarded \$108,868.18 as reasonable and necessary fees and costs for services rendered and costs incurred from January 1, 1999 through November 11, 1999 to monitor and enforce the Court's orders pursuant to 42 U.S.C. § 1988. Said amount shall be remitted to Heller Ehrman White & McAuliffe on or before December 24, 1999;

2. Heller Ehrman White & McAuliffe is owed \$9,355.41 and interest in the amount of \$279.48 for a total of \$9,634.89 pursuant to a stipulated order entered on April 9, 1999. Said amount shall be remitted to Heller Ehrman White & McAuliffe on or before December 24, 1999.

3. This Stipulation and Order does not address or otherwise resolve any fees or costs that have been or may be incurred after November 11, 1999 or the fees and costs associated with the appeal in this matter.


