5 The Court, having reviewed the Stipulation for Approval of Settlement, the Declaration  
6 of Counsel, the pleadings and other materials on file herein, and good cause appearing therefor:

7 IT IS HEREBY ORDERED that the settlement of the claims for monetary relief as  
8 described in the Stipulated Motion be and the same hereby is approved.


9 IT IS FURTHER ORDERED that any and all class based claims for monetary relief be  
10 and the same hereby are dismissed with prejudice; however, the claims for monetary relief of any  
11 absent putative class members not identified on Exhibit 1 to the Stipulated Motion for Approval  
12 of Settlement are dismissed without prejudice.

13 IT IS FURTHER ORDERED that upon the approval by this Court of the compromise of  
14 any claims brought by minor plaintiffs-putative class members and the full and final payment of  
15 the settlement sum to the plaintiffs' counsels' client trust account, then the monetary relief  
16 claims of the individual plaintiffs-putative class members identified on Exhibit 1 to the  
17 Stipulated Motion for Approval of Settlement will be dismissed with prejudice.

18 The Court hereby retains jurisdiction over plaintiffs' claims for non-monetary relief.

19 IT IS SO ORDERED.
