This motion is unopposed. The standard for a motion for reconsideration is "strict." <i>Shrader v. CSX Transp., Inc.</i> , 70 F.3d 255, 257 (2d Cir. 1995). "The major grounds justifying reconsideration are 'an intervening change of controlling law, the availability of new evidence, or the need to correct a clear error or prevent manifest injustice,'" <i>Virgin Atl. Airways, Ltd. v. Nat'l Mediation Bd.</i> , 956 F.2d 1245, 1255 (2d Cir. 1992) (quoting 18B C. Wright, A. Miller, & E. Cooper, <i>Federal Practice & Procedure</i> § 4478), and reconsideration should be granted only if "the moving party can point to controlling decisions or data that the court overlooked matters, in other words, that might reasonably be expected to alter the conclusion reached by the court," <i>Shrader</i> , 70 F.3d at 257. Because the Court has now been advised that Defendants lacked opportunity to respond to the Governments motion before it was granted, their <u>44</u> Motion for Reconsideration is GRANTED. Defendants are directed to file by July 6, 2011 their memorandum in opposition, including their analysis of why the balance of interests weigh against the partial stay of discovery imposed, specifically identifying the items of discovery they have sought or believe they are entitled to in this case, which have been precluded by the stay.
