ORDER

Pursuant to the status reports filed on January 12 and 17, 2007 and the status conference on January 17, 2007, and upon consideration of the plaintiffs' Motion to Lift Stay of Discovery, it is by the Court hereby

ORDERED that plaintiffs' Motion to Lift Stay of Discovery [Dkt. No. 311] is **GRANTED**; and it is

FURTHER ORDERED that the Court lifts the stay on all discovery except for the discovery directed at officers who have been sued in their individual capacities and have pending qualified immunity motions in either this case and/or the Chang case, including Richard Murphy, Bryan DiGirolamo, Andre Harrison, Michael Smith, Michael Fitzgerald, and Brian Jordan; and it is

FURTHER ORDERED that the parties in the Chang and Barham cases shall continue to coordinate for purposes of pre-trial discovery; and it is

FURTHER ORDERED that discovery shall resume effective immediately and shall conclude by no later than **NOVEMBER 16, 2007** as to all matters other than those areas excepted above; and it is

FURTHER ORDERED that the Court should be promptly informed of any discovery disputes that the parties are unable to resolve among themselves, should they arise; and it is

FURTHER ORDERED that depositions for Charles Ramsey and Peter Newsham shall take place by no later than **AUGUST 24, 2007;** and it is

FURTHER ORDERED that plaintiffs' Motion to Quash the District's Defective Offer of Judgment [Dkt. No. 193] is **DENIED WITHOUT PREJUDICE** as it appears to be mooted by the District's most recent Offer of Judgment [Dkt. No. 302] accepted by some of the plaintiffs; and it is

FURTHER ORDERED that defendant District of Columbia's Motion for Partial Summary Judgment [Dkt. No. 230] is **DENIED WITHOUT PREJUDICE** to refile at the close of discovery; and it is

FURTHER ORDERED that the parties shall submit a joint report and recommendation for further proceedings by **NOVEMBER 30, 2007;** and it is

FURTHER ORDERED that a status hearing is scheduled for **DECEMBER 12, 2007 at 11:00 a.m.**
