### VIPD'S STATUS REPORT FOR QUARTER ENDING AUGUST 21, 2015

This Progress Report is submitted pursuant to the mandates established by the United States District Court in the Civil Order 2008-158 and amended on May 22, 2014.

#### USE OF FORCE

***“Authorize and contract training for Force Review Board personnel”*** - This training was initially scheduled for August 10, 2015 by the FBINA, but was pushed back to the latter part of August, specifically August 24-28, 2015 at the request of the FBINA. However, due to “Hurricane Danny”, this training was postponed and a new date is not yet determined.

***“Conduct training for Force Investigation Team (FIT) personnel”*** - Individuals from both Districts identified as members of FIT attended and completed shooting reconstruction training at North Western University, Illinois, from June 22-24, 2015. A course outline for this training was provided to IMT and USDOJ on May 14, 2015. Electronic copies of certificates for the completion of this course were submitted to IMT /USDOJ July 30, 2015. An on-site follow-up training was planned for August 24-28, 2015 by the FBINA for CIB (Criminal Investigation Bureau) personnel and select Attorneys from the VIAG subsequently selected to be a part FIT. This will be conducted once

*a new training date is established. Copies of the applicable policies were already forwarded to the Instructors for their review prior to the initiation of this training. Also, Course outline associated with this training was forwarded to IMT. Biographical information for the Instructors of these trainings was submitted to IMT/USDOJ August 9, 2015.*

***“Develop O.C. Spray Matrix Chart”*** - matrix was prepared this quarter.

#### MANAGEMENT AND SUPERVISION

***“IAPRO Application Training for Commanders and Managers”*** - The VIPD has completed this training for Commanders and Managers in both Districts during this quarter.
