THIS MATTER having come before the court by way of an order to show cause filed on May 11, 2020, seeking relief by way of temporary restraints against the implementation of any internet voting systems for elections in the State of New Jersey; and the court having held a case management conference on May 18, 2020, to discuss scheduling of this matter; and Deputy Attorney General Susan Scott, counsel for Defendants, having represented that the State does not

intend to use an internet-based voting system of the kind challenged by Plaintiffs for future elections; and Mary A. Ciccone, Esq., counsel for Disability Rights New Jersey, having filed a motion for leave to appear on behalf of Defendants as *amicus curiae*; and for good cause shown:

IT IS ON THIS 19th day of May, 2020, **HEREBY ORDERED** that:

1. The parties shall cooperate in an effort to reach a written memorandum or agreement addressing the use of internet-based voting systems for future elections.
2. The parties shall file letters updating the court as to the status of their discussions by June 8, 2020.
3. The court shall consider Disability Rights New Jersey's motion for leave to appear as *amicus curiae* if and when this matter is scheduled for further proceedings.
